RELEASE & WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of the services of Whippoorwill Rodeo, LLC and the True American Cowboy Tour and its representatives or agents herein referred to as "releases", (collectively, "Whippoorwill Rodeo, LLC and the True American Cowboy Tour), and other good and valuable consideration, the sufficiency of which I (the undersigned), do hereby acknowledge, on behalf of myself and all persons" below:

IN CONSIDERATION of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as including but not limited to the rodeo arena, competition area, chutes, pens, areas reserved and intended for participants or restricted to the general public, and all walkways, concessions, and other areas appurtenant to any area where any activity related to the event shall take place) or being permitted to compete, officiate, observe, work for, volunteer, or for an purpose participate in any way in the event, THE UNDERSIGNED, for themselves, their personal representatives, heirs, and next of kin, acknowledges, agrees and represents that the undersigned has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which they enter and with which they come in contact, and the undersigned does further warrant that their entry upon such restricted area or areas and their participation, if any, in the event constitutes and acknowledgment that the undersign has inspected such restricted area and that they find and accept the same as being safe and reasonably suited for the purposes of their use, and they further agree and warrant that if, at any time, they are in or about restricted areas and they feel anything to be unsafe, they will immediately advise the officials of such and leave the restricted areas.

1. **HEREBY VOLUNTARILY RELEASES, WAIVES, DISCHARGES, AND CONVENANTS NOT TO SUE** the participants, sanctioning organizations, or any subdivision thereof, rodeo committee, stock contractor, rodeo association, arena operators or owners, officials, any persons in restricted areas, promoters, sponsors, advertisers, owners, and lessees of premises used to conduct the event and each of them, their representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the event.
2. **HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted are or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by negligence of the releases or otherwise.
3. **HEREBY VOLUNTARILY RELEASES, WAIVES, DISCHARGES AND HOLDS HARMLESS** Whippoorwill Rodeo, LLC and the True American Cowboy Tour from any and all liability claims, demands, or causes of action (including but not limited to any and all claims alleging negligent acts or omissions of Whippoorwill Rodeo, LLC and the True American Cowboy Tour) which are in any way connected to participation in any activities of Whippoorwill Rodeo, LLC and the True American Cowboy Tour or in relation to Whippoorwill Rodeo, LLC and the True American Cowboy Tour operations. I further waive and release all rights (if any) that may or could arise under the Animal Control Act or the Equine Activity Liability Act, whether or not my activities are deemed to be sponsored by an equine activity sponsor and whether or not Whippoorwill Rodeo, LLC an the True American Cowboy Tour is deemed to be equine professionals. I understand that voluntarily accepting responsibility for controlling any animal at a Whippoorwill Rodeo, LLC and True American Cowboy Tour event places me within the definition of an "owner" under the Animal Control Act and, therefore, I cannot recover any amount from the animal's legal owner.
4. **HEREBY ACKNOWLEDGES AND ASSUME ALL RISK** that rodeo equipment including but not limited to chutes, gates, panels, fencing, ropes, rigging, saddles, arena surfaces, vehicles, and related equipment, may fail, malfunction or be improperly maintained. I expressly assume all risks of injury, death, or property damage arising from equipment failure, malfunction, defect, improper maintenance, or human error, including those caused by negligent acts or omissions of Whippoorwill Rodeo, LLC and the True American Cowboy Tour and their owners, officers, agents, employees, contractors and affiliates, to the fullest extent permitted by law.
5. **THE UNDERSIGNED** consents to being photographed and/or videotaped during participation in any Whippoorwill Rodeo, LLC and True American Cowboy Tour event or event Whippoorwill Rodeo, LLC is hired and involved with, and consents to the use of those photographs or videotapes in the promotion of Whippoorwill Rodeo, LLC and the True American Cowboy Tour events, including but not limited to their use in promotional literature and their release to print media, social media, television, or other electronic media.
6. **HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, ILLNESS, DEATH, OR PROPERTY DAMAGE** due to the negligence of releases or otherwise while or upon the restricted area and /or while competing, officiating, volunteering, observing, or working for, or for any purpose participating in the event. THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and for property damage. THE UNDERSIGNED acknowledges the risk specifically related to COVID-19.
7. **I have had sufficient opportunity to read this entire document. I have read and understood this document, and I agree to be bound by its terms. By signing this document, I bind myself and all persons named below, my spouse, heirs, legal representatives, assigns, insurers, and successors.**

I HAVE READ THIS DOCUMENT, I UNDERSTAND IT IS A RELEASE OF ALL CLAIMS. I UNDERSTAND I ASSUME ALL RISK INHERENT TO RODEO/EVENT. I VOLUNTARILY SIGN MY NAME EVIDENCEING MY ACCEPTANCE OF THE ABOVE PROVISIONS. I HAVE THE AUTHORITY TO BIND EACH PERSON NAMED BELOW, AND THIS RELEASE AND CONVENANT NOT TO SUE SHALL APPLY TO EACH SUCH PERSON (UNDERSIGNED)
